Instructions for completing NWRGSL Referee Match Report – This is a legal document, please be accurate and thorough

1. Date of match
2. Time of match
3. Field where match played (ACC1, ASC1, ASC2, ASC3, BSF1, etc. – Please use field codes from match schedule)
4. Match level (U6G, U8B, etc.)
5. Referee Name
6. Assistant Referee #1 Name and Classification (MUST indicate if AR used)
7. Assistant Referee #2 Name and Classification (MUST indicate if AR used)
8. Team names and numbers
9. Team colors
10. Team captains
11. Final scores
12. Information required for any Caution/Send-Off are:
 - a. Whether Caution of Send-Off (Indicate C or SO)
 - b. Player's Number
 - c. Player's Name
 - d. Reason for Caution or Send-Off (Please use codes below)
 - Cautionable Offenses:
 1. **UB** – Is guilty of unsporting behavior
 2. **DT** – Shows dissent by word or action
 3. **PI** – Persistently infringes the laws of the game
 4. **DR** – Delays the restart of play
 5. **FRD** – Fails to respect the required distance when play is restarted with a corner kick, free kick or throw-in
 6. **E** – Enters or re-enters the field of play without the referee's permission
 7. **L** – Deliberately leaves the field of play without the referee's permission
 - Sending-Off Offenses:
 1. **SFP** – Is guilty of serious foul play
 2. **VC** – Is guilty of violent conduct
 3. **S** – Spits at an opponent or any other person
 4. **DGH** – Denies the opposing team a goal or an obvious goal-scoring opportunity by deliberately handling the ball (this does not apply to the goalkeeper within his or her own penalty area)
 5. **DGF** – Denies the opposing team a goal or an obvious goal-scoring opportunity by an offense punishable by a free kick or a penalty kick
 6. **AL** – Uses offensive, insulting or abusive language and/or gestures
 7. **2CT** – Receives a second caution in the same match
 - e. Time of Infraction
13. Rate the coaches/players/spectators on their behavior during the match by circling the appropriate number (5 is exemplary, and 1 is unacceptable). Additional detail should be provided in Section 14 for any area rated either 5 or 1.
14. Comments – a more complete explanation of any Caution or Send-off should be given here; comments on field conditions; coach, player and spectator behaviors; tie-breaking activities; etc. Additional sheets may be attached if necessary.
15. Sign and date the form
16. Match reports should be submitted within one week after completion of the match.
